I, for myself and on the behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Philadelphia Furniture Workshop its members, employees, agents, or others, and the owners of the Premises used for the activities, WITH RESPECT TO ANY AND ALL INJURY OR DISABILITY, WHETHER ARISING FROM THE NEGLIGENCE OF THE COMPANY OR OTHERWISE, to the fullest extent.

5. I agree that the Company may use and publicly display (both in print format and on its website), without any compensation or notice to me, any photographic image or likeness of me taken during the course for the purpose of promoting Philadelphia Furniture Workshop.
